# MEETING MINUTES

## MPLC ANNUAL CONGREGATIONAL MEETING

## FEBRUARY 11, 2024 KRISTI BARRETT - SECRETARY

- CALL TO ORDER KIM HAIGH
  - Kim Haigh called the Annual Congregation Meeting to order at 10:15 AM.
- OPENING LITURGY: PASTOR BETH ANN STONE
  - Pastor Beth Ann led the opening liturgy.
- OZ ESTABLISHING A QUORUM KIM HAIGH

A quorum was established with more than 115 in-person attendees and 11 online voting members.

- APPROVE ANNUAL MEETING MINUTES KIM HAIGH
  - The minutes from the Annual Meeting held on February 5, 2023, were approved by unanimous consent.
- 05 REPORT OF CONGREGATION COUNCIL PRESIDENT

Kim Haigh provided an overview of the agenda for the meeting. She expressed her gratitude for the positive changes within the congregation and the new relationships she has fostered within the church community.

06 REPORT OF PASTOR BETH ANN STONE

Pastor Beth Ann Stone shared updates from her written report. She reflected on the past six years and expressed deep gratitude for the congregation's support. She thanked everyone who stepped up to give and contribute during that time.

Pastor Beth Ann announced that the council has honored her request for a 12-week sabbatical from April to early July. She shared that a grant from the Lilly Foundation has provided nearly \$36,000 to support her and the congregation during this period. She also thanked the departing council members for their service and leadership.

We fully welcome you to join us, embracing your race, culture, ethnicity, age, gender identity and expression, sexual orientation, physical abilities, mental abilities, socioeconomic position, family status, background, and wherever you are in your faith journey. You are a unique and beloved child of God and are welcome here. You are accepted and openly affirmed just as you are. We commit ourselves to undertaking the work of racial equality and social and economic justice. We invite you to join us as we joyfully and inclusively love and serve God and our community, as we are all one in Christ Jesus."

#### DALE & JAYNE ARMBRUSTER

# TREASURER'S REPORT

## SUMMARY OF 2024 FINANCIAL REPORTS

#### Total Income was \$656,737

Which was \$31,737 greater than budget and over \$12,000 larger than 2023

- Member giving was \$3,000 less than 2023, but plate giving was \$1,000 more
- Investment income was \$13,000 higher than 2023 due to the strong financial markets in 2024

Total Expenses were \$638,822, \$13,822 greater than budget, but \$5,764 less than 2023

- The mortgage was paid off from Designated Funds this summer.
- The Communications Director resigned in spring, so Salaries/Benefits were less than budgeted.
- Converting to a new computer security system, pastor legal consultations and a change in our accounting firm's billing policies accounted for an increase in Administrative expenses.
- A substantial increase in insurance costs, snow removal, landscape maintenance and building maintenance expenses due to the water leakage in our education wing accounted for an increase in Building & Property Costs.
- Ministries of MPLC were under budget by \$3,000.

# As a result, MPLC ended the year with a positive surplus of \$17,915 which has been added to the Capital Fund balance established in prior years.

• The current Capital Fund balance of \$206,525 reflects the cumulative surplus available to fund significant maintenance projects, unexpected repairs and building upgrades that cannot be funded through the annual operating budget. Since the church's six furnaces are reaching the end of their expected lives and the water leakage in the education wing needs to be further addressed, this fund will be extremely important in the future.

# The congregation's balance sheet is strong with plenty of cash and reserves on hand.

- At the end of 2024, we had \$134,287 in the checking account and \$304,730 in our savings/investment accounts.
- Designated accounts total \$439,017. Council voted to use the Georgia Heffel Memorial Fund of \$94,000 for an additional source of funds for the building leakage issues as needed, in addition to the Capital Fund. Memorials and Special Gifts total \$23,840 and Mission and Ministry Funds are \$36,325.

## THANKS AND RECOGNITION

It has been a privilege being MPLC's Treasurer this year, and I'd like to thank our previous Treasurer, Kara Reske, Pastor Beth Ann, and our Business Manager, Jessica Sexton, for making this a smooth transition. I have been working closely with Jessica Sexton on internalizing our accounting functions as we transition away from our accounting firm, CLA, and she deserves many thanks for all the time she has put into taking on this additional role!

I would also like to thank the newly established Finance Committee of Dick Davies, Ron Londre, Gary and Janet Henseler, and Pastor Beth Ann for all of their work in helping me develop our 2025 budget, and for their invaluable insights and advice on ongoing financial matters of MPLC. Finally, thank you to our current Offering Counters, Karen Magee and Rita Lewis, and our newly established second Counting Team of Cindy Green and Jan Fuller who faithfully count the income MPLC receives each week.

# 2025 PROPOSED BUDGET - SUMMARY

## Susan Bakken - Treasurer

#### Total Budgeted Income was left at the same as the 2024 budget because:

- Member giving was similar to 2023 (slight decrease of \$2,000 total in 2024).
- The number and amount of 2025 Pledged Offerings have decreased from 2024 Pledges received, but Plate and Non-Pledged Offering increased slightly during 2024. With less Pledged Offering to count on in our income forecast and the current concerns in this country about the higher costs of living, we cannot as accurately predict how much income we will receive in 2025. Our hope is that if we see an increase in giving during 2025, we will be able to forecast increased income for the 2026 budget, but for now, there are too many unknowns to assume our income will increase in 2025. Based on our current 2024 Mission & Ministry receipts however, it is reasonable to assume we will receive similar income in 2025, especially with Pastor Nathan Pratt joining us as a full-time staff member.
- Investment income increased substantially from 2023 (almost \$13,000).

# Total Budgeted Expenses for 2025 will also remain the same as 2024 and were adjusted based on actual 2024 expenses or recategorization of expenses:

- The benevolence budgets will continue at 10% of 2025 expected income (\$60,500).
- Average salary increases of 3% are assumed and include full year salary projections for all current pastoral and staff positions. However, both Salaries and Benefits Totals have decreased due to the reduction of our future Communications staff member hours to 6-8 hours a week and different recommended levels of pastoral compensation for Pastor Sheila and Pastor Nathan.
- 2025 Administrative Costs decreased due to internalizing all our accounting functions other than
  payroll. The \$20,000 savings we will recognize from doing this will cover expected increases in our
  budget for 2025, including a more secure computer monitoring service, increased insurance,
  utility, snow removal and landscaping costs, Pastor Nathan's Transition expenses, as well as
  increased building maintenance costs as our building ages.
- The MPLC Ministry budgets have increased as our congregation has been able to gather together
  more as the dangers of the pandemic continue to recede. We have also budgeted for the
  celebration of the 50th anniversary of our MPLC building in the Fall of 2025. It is important to
  focus on these opportunities for our congregation to connect with and support one another.

# CONGREGATIONAL COUNCIL SECRETARY - ERIN BRALEY DONALDSON

I am excited to share the significant decisions and notable discussions that impacted our MPLC community in 2024 which will shape the congregation we become in 2025 and beyond.

## WELCOME TO ALL

With the guidance of the Beyond Welcome committee, Mount Pleasant Lutheran became a Reconciling in Christ church. Additionally, we are now listed on the GALIP website (<a href="www.gaychurch.org">www.gaychurch.org</a>), thus solidifying our commitment to "Growing relationships with God, each other and our neighbors in the way of Jesus".

### MEMORIAL GIFTS

Council members voted to welcome new members throughout the year. We also said "good bye" to members who blessed our church with generous gifts in memorium. Some of the gifts given include funding for a tree for our labyrinth garden, a new timpani drum, sound dampening panels for Fellowship Hall, and funding for our pending building project. We are grateful for each gift.

## WORKPLACE POLICIES

In 2024, there were several workplace decisions that were impactful. After it was recognized that additional IT security was needed, it was approved to work with a new IT management service. An addition to the employee manual was approved regarding workplace flexibility to address flex-time and remote work for church staff. Finally, the MPLC Child Protection Policy was reviewed and revised for the first time since 2022 adding language regarding communication with minors. The safety and well being of our congregation and staff is always a priority.

## CHURCH BUILDING ISSUES

The ongoing water mitigation project continues into 2025. Council members have learned a lot about exactly how unique our "spaceship" truly is. Many options to address the leaking building and skylights have been discussed and debated. It will not be an easy project but Council is committed to solving it so our church and education wing can be our home for another 25+ years.

### LOOKING AHEAD

Throughout the year, we have educated ourselves through relevant and interesting videos and articles about the evolving needs of the church in the larger community of Racine and beyond We discussed emerging trends in membership and participation in faith. The Council hopes to have gained insight into our history and current trends to prepare ourselves to lead into the future.

## **CALL PROCESS**

Finally, and most excitedly, our Call Committee resumed and, following training and interviews, presented Council with a recommendation for a new associate pastor. Upon reviewing his biography and discussion with the Call Committee, Council was thrilled to accept the Call Committees recommendation. On November 17, 2024 the recommendation was brought to the congregation and it was overwhelmingly approved. In December Nathan Pratt officially became Pastor Nathan and will be welcomed as our new pastor in January of 2025.

We, as your MPLC Council, look forward to continuing our work with you in 2025.

# MEMORIALS COMMITTEE

Functioning is its role as the Memorial Committee (as designated by MPLC's constitution), the Congregation Council approved designating gifts given in memory of Shirley Krekling for new Fellowship Hall sound dampening panels; gifts given in memory of Richard Jonas were assigned to the Endowment Fund; gifts given in memory of Doris Cecchini were given to be used for a new tree in the Labyrinth; and gifts given in memory of John Friend and Cathy Spatz will be used to refurbish the new Fellowship Hall Annex room (formerly known as the "old nursery").

# SENIOR PASTOR

### PASTOR BETH ANN L. STONE

I've been thinking lately about liminality. "Liminality" refers to a transition, an in-between time. It comes from the Latin word for "threshold", like a door between two spaces. The place of liminality is where you are when you've left one space and before you've entered the next.

As a church we've experienced liminality as we looked forward in 2024 to calling a new associate pastor, and also while we partnered with Transition Associate Pastor Sheila Rawn. Pastor Sheila was with us at 80% time from October 1, 2022 until January 15, 2025...nearly 28 months. Her gifts for counseling and preaching blessed many in our community. I am grateful for the consistency and support she provided us, for her leadership during my sabbatical, and for the playful spirit she brought to MPLC.

Now as I write these words, we are welcoming Pastor Nathan Pratt, who began his call as our full-time Associate Pastor on January 16, 2025. Pastor Nathan will surely also leave his imprint on our congregation in the months and years ahead as he taps his spiritual gifts and invites other people to share theirs. It's been a joy to prepare for his arrival and to begin to dream about God's plans for MPLC with a second full-time pastor on board!

I am grateful for the three-month sabbatical I received earlier this year, and for the positive effect that time of "unplugging" has had on me since then. With that much needed "reset", I feel like a more balanced, less anxious, and more capable leader today than I was a year ago. Thank you, MPLC, for that gift and for your support!

We are so blessed to work with talented, hard-working staff members at MPLC. I thank God for Becky, Jessica, Greg, Dimitri, Rick, and Michael for what they all add to the ministry we share. I also give thanks for our Congregation Council and the Executive Committee for their fine work this past year, too. MPLC is a special place; I'm lucky to be a part of it!

## REMEMBERING 2024

The year 2024 may be remembered for several notable events that are detailed in other reports in this publication: the vote to be a "Reconciling in Christ" congregation, MPLC t-shirts ordered in a rainbow of colors, our youth's participation in the 2024 ELCA Youth Gathering in New Orleans, and the debut of new, sky-blue choir robes for the Senior Choir.

During my sabbatical, MPLC experienced worship led by several neighboring pastors and retired pastors from the congregation, as well as by Pastor Sheila. Members also had the opportunity to attend a Retreat in Daily Life and individual Spiritual Direction sessions, supported with funding from the Lilly Endowment National Clergy Renewal Program grant that MPLC and I received. The grant also funded sessions of chair and outdoor yoga, tying to that aspect of my sabbatical plan, as well.

Christian Education opportunities for adults in 2024 included "Women, Wine and the Word" led by Pastor Sheila, the monthly Men's Breakfast led by Stephen Gifford, Wednesday AM Bible Study led by the pastors, an online study of "Hymns of Epiphany" led by Karen Gosselin, a summer book study of "The Color of Compromise" led by Karen Gosselin, and a 6-session study of "Civic Life and Faith" led by members of the Beyond Welcome Team. Pastor Sheila and Sharon Mantey led a 13-week GriefShare small group, including a special open workshop on "Surviving the Holidays".

Last spring, Michael Becker celebrated fifteen years on our staff as our church musician. He is a gift to our worship life and community! Laura Gleason left her position of Communications Director in March, leaving a vacancy that remains at this writing. Becky Litwin and I assumed those duties on a temporary basis until a new person is hired.

In worship, our Saturday service time was kept at 4 PM during the year, except for the weekends of Memorial Day through Labor Day when it was moved to 5 PM. We continue to have one Sunday service at 9:00 AM all of 2024, and to livestream that service on Facebook and YouTube. An outdoor service and church picnic took place in July at the Pritchard Park shelter and was a great re-entry for me after my sabbatical. After our fall kickoff worship service in September, members gathered in the Fellowship Hall to brainstorm "What's the Big Idea". We hope their ideas for future ministries will grow legs in 2025!

In property changes, the two parking lots were resurfaced and repainted last spring. Member mailboxes were all moved to the right side of the narthex, and a Donation Station was installed on the left side, providing a place for in-kind donations to be collected and organized. In December, the church contracted with a company for managed IT services, providing greater stability, security and support for our computers and internet systems.

A new Finance Committee began to meet in last fall with Treasurer Susan Bakken to assist with fiscal oversight of the congregation. Late in 2024, our Safety Team was revived after several years of dormancy. They have begun to work on updating our safety protocols, interior signage, and other measures to protect the well-being of people and property. A team was also formed to prepare to celebrate the sanctuary building's 25th anniversary in 2025 with several special, fun events. These newer teams will have more to report in next year's Annual Report.

# 2024 CONTINUING EDUCATION

All pastors are encouraged to participate in continuing education experiences annually to help develop their skills, deepen their faith, and enhance their ministry. In 2024, my CE experiences included:

- On Monthly meetings with my spiritual director over Zoom, and yoga,
- O2 Study Trip "In the Footsteps of St. Paul" to Greece and Turkey sabbatical
- O3 An immersive course on "Building a Tiny House" sabbatical
- O4 Retreat at Holden Village in Chelan, Washington sabbatical
- O5 Anti-racism module and other online learning for adult chaperones for the 2024 ELCA Youth Gathering
- A one-day learning event of the synod on pastoral boundaries
- 07 A post-sabbatical retreat at the Spent Dandelion Retreat Center





# MINISTER OF MUSIC DR. DIMITRI SHAPOVALOV

It is with feelings of joy and pride in our music programs that I submit this report for the 2025 congregational meeting. As I was last year, this year too I'm pleased to report that the music program at MPLC is thriving.

Our most musically active ensemble, the senior choir has provided special music and participated in liturgy for most of the Sunday worship services that take place between September and May, also contributing to the special music services on Ash Wednesday, Palm Sunday, Maundy Thursday or Good Friday, Easter Sunday, and Christmas Eve. As of January 12, 2025, the choir's membership stands at 27 singers, with roughly 18 to 20 attending any given rehearsal or singing in a worship service. This is 2 fewer as compared to last year, but the losses include Pastor Sheila Rawn, who



has left this church as part of a planned transition, and another member who left because of the appointment associated with that transition. Additionally, Lois Solberg and Maxine Silvius have transitioned to alumni status due to health concerns but remain part of the congregation. Since last year, we have also welcomed two new members who joined MPLC specifically to sing in the choir: Karen Krey, and Anil R.K.

Michael Becker's musical gifts continue to form the foundation of the musical offerings at MPLC. His assistance at the piano and organ is indispensable to the choral program, and also in solo/duet opportunities.

The bell choir continues its strong performance tradition, offering an anthem every four weeks or so, thanks to the excellent leadership of Greg Schroeder. At select services, the bell choir treats us with more than one anthem, proving their capacity for prodigiousness and versatility. Its presence remains of special importance to our community, as this ensemble's roster provides opportunities for collaborating with the adult choir and other musicians of MPLC.

The children's choir continues to offer musical gifts and has increased its ranks this fall. This past December, the choir performed two anthems as part of the annual Christmas Children's Program, and they contributed one more anthem in October. We are blessed to have such a strong commitment to music among the Sunday School participants. A special thanks to Becky Litwin for coordinating the children's program, communicating with Sunday School parents.

The choir offered two Music Sundays this year: in May and in December. Our May program followed the by now traditional model of selecting a few anthems sung in the weeks prior and presenting them as a musical unit as part of the worship service on a single Sunday. For our December Music Sunday, we sang Daniel Pinkham's challenging Christmas Cantata, with Michael Becker supporting the choir on the organ. This was a momentous accomplishment for the choir: the cantata posits tremendous technical demands on the singers. Its writing is difficult, and it requires considerable expertise to master. I couldn't be more proud of the singers in the choir: they rose to the occasion and thus furthered their already impressive musical growth.

As in the past, we have been blessed to have several solo musicians who have signed up to do solos and duets throughout the year, including Amy Obernberger, Letty Jocius, Kevin Jocius, Kristin Brandt, Paul Pruessing, and others. I am thankful for their dedication and talent.

"We were blessed to have two individuals [not members of the Beyond Welcome Committee] volunteer to lead Adult Education to provide educational opportunities that support our Welcome Statement objectives. Dimitri Shapovalov presented how/why Personal Pronouns are important to the LBGTQ+ Community by sharing his relationship and first-hand experience with college students at Carthage. Karen Gosselin led a six-week course on "The Color of Compromise" written by Jamar Tisby, an ordained minister, historian, and author. The book surveys historical periods in North America from the beginning of slavery to the present showing how the American white churches have been complicit in creating and maintaining racism." - Donna Braaten

"One of the advantages of having a larger committee is that we can generate excitement at our meetings and ideas begin to explode like popcorn. - Yolanda Lewis and Donna Braaten attended the ELCA synod event "Loosening the Bonds" Building RIC and Anti-Racist leaders and congregations.
- Beginning in September, MPLC was added to the listings in the GayChurch.org Directory, an Affirming Worldwide Christian Directory. The mission of The Galip Foundation, sponsors of the Directory, is "to connect people with local church congregations so they can visit and, if they choose, can get involved."

We look forward with humble excitement to planning our main goal for 2025, as well as working on other projects related to all the goals set forth in MPLC's RIC Welcome Statement.

# CHILDREN & FAMILY MINISTRY

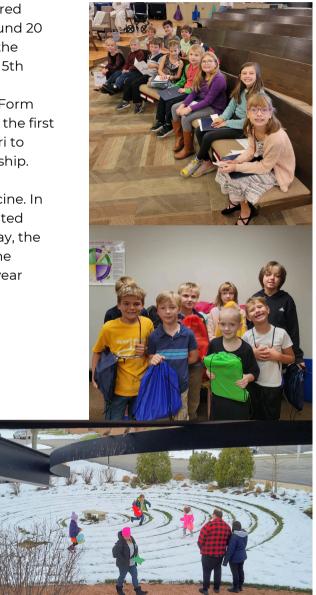
# **Becky Litwin**

Our current Sunday School program has 28 registered children and 7 volunteer teachers. We average around 20 kids weekly. Our 3-year-old – 5-year-olds are using the "Godly Play" Montessori model again this year. 1st – 5th grades are using the Sparkhouse Whirl – All kids curriculum. 6th, 7th, & 8th grades are using the Re:Form curriculum. Grades 1 – 8 meet in the Choir room for the first 15 minutes of Sunday school each week with Dimitri to practice music that is periodically sung during worship.

In February, we painted bowls for Empty Bowls Racine. In March, we had a Palm Sunday party where we created crafts and had an Easter egg hunt. At the end of May, the kids sang and participated in different aspects of the worship service. Afterwards, we had an end of the year party with games and ice cream sundaes.

Our weekly offerings were given to God's Global Barnyard. We were able to raise enough money to buy a community garden and two honeybee colonies for a community and farmers in need.

June marked two VBS for All Sundays. Worship services focused on stories and songs of the Old Testament, in early June, and the New Testament, in late June. We collected items to help fill our Little Free Food Pantry. Coffee hour had special treats, crafts, and games for all to enjoy.



Our 2024 -25 Program year began on September 8th with "Serve" Sunday. The kids worked to put together School Kits for Lutheran World Relief. Our Middle school kids joined the Adult Ed "Big Idea" session and came up with their own big idea to implement in the church.

In October & November, we had two more Serve Sundays, making dog toys that were donated to the humane society and Chicken Noodle soup packets to be added to the gift bags created for our homebound members during the Christmas season. We also hosted another Empty Bowls painting event. Each child's fee to paint was covered by a \$250 Thrivent grant.

We ended the year 2024 with a Christmas Program where we told the Christmas story during the Sunday worship service. Afterwards, we had a delicious pancake breakfast and games and crafts for all.

We are truly grateful for our dedicated volunteers that help to keep our program running smoothly.

# Community Meal

# Little Free Food Pantry

In the fall of 2020, MPLC member Stew Nagao was asked to make and install a Little Free Food Pantry in front of the church building. "Take what you need, leave what you can" is the motto for this shared space for giving or receiving easy-open foods. The pantry is used several times a day by neighbors, passersby, and members donating or picking up items.

In 2024, the pantry was moved directly next to the church entrance. Members may place donations for the pantry in the labeled bins in the church's "Donation Station" area. Or put donated items directly in the pantry whenever you see there is space available.

In January 2025, the LFFP was damaged in a vandalism incident. Stew Nagao worked to restore and replace the LFFP in its usual spot within two weeks.

## LONG-TERM BUILDING COMMITTEE

The long-term building committee's primary focus in 2024 has been on water intrusion issues in the Education Wing. It has also included evaluating a cost estimate and schedule for five aging HVAC units.

### Water Intrusion Issues

Dating back to 2022, MPLC started working with a construction management firm, Rossi Construction, to address water intrusion issues in the basement of the church, the most problematic of which is in the Education Wing. Proposals were solicited from a civil engineering firm (Nielson, Madson, & Barber (NMB) and an architectural firm (Plunkett Raysich Architects (PRA)) to develop recommendations and plans to address the issues. These firms evaluated the water intrusion issues and provided recommendations.

Based on the recommendations, NMB ultimately prepared an engineering design plan set in 2024 to use for bidding and construction. In general, the design included a combination of gutters along the church roof, catch basins and drain tiles, skylight replacement, a new liner system above the Education Wing, and regrading around the building. Rossi Construction lead the contractor solicitation of bids and bid reviews.

Originally confidence was high that the water issues could be resolved based on the NMB design. Upon Rossi Construction's consultation with a few different contractors, a concern arose about the load bearing capacity of the ceiling of the Education Wing. Contractors were uncomfortable bidding on the project without knowing if the celling of the Education Wing could bear the load of the weight of their construction equipment. Only one contractor issued a bid, and the bid was determined to be tens of thousands of dollars higher than expected by Rossi Construction and it was assumed that the contractor's bid reflected the uncertainty of the load bearing capacity of the celling of the Education Wing.

Upon review of this concern and the design, another concern about the cost and long-term viability of the NMB design arose. The design addresses the need to direct water away from the Education Wing, but it did not address any damage or defects in the celling of the Education Wing. If the project were to move forward as designed, any defects or damage would remain unrepaired.

As more research has been conducted, and in addition to the above, it is likely that the Education Wing subterranean roof system has reached the end of its functional life and needs to be replaced. That would require the temporary removal of the earth and roofing layers covering the

Education Wing. This greatly magnifies the scope and cost of this project. Cost estimates have been difficult to obtain due to scope uncertainty and slow responses from Rossi Construction and the many contractors required.

The Long-Term Building Committee decided to evaluate additional water mitigation alternatives. The alternatives have included:

- having a foundation specialist evaluate the water intrusion and submit a bid,
- consult with material manufactures and contractors to determine if options exist for repairing the roof of the Education Wing using similar or improved materials in a similar manner as the Education Wing was originally constructed,
- · requesting proposals from architectural firms to provide alternative conceptual designs, and
- obtaining a bid from a landscape contractor to do temporary, minor regrading above the Education Wing until a more permanent solution can be found.

The foundation specialist determined that they would only be able to address leaks originating from the side walls of the Education Wing and not from the celling of the Education Wing. The material manufacture of the material that was originally used to seal the roof of the Education Wing commented that the material was not intended to be used for subterranean structures. The contractors that were consulted provided alternative sealing options and offered to provide contact information for others that may be able to perform the work. The one architectural firm submitted a proposal for three different conceptual design ideas. The options offered in the proposal included:

- variations on a subterranean roof system,
- an exposed roof system,
- an exposed roof and wall system, and
- a green roof tray system.

The bid on temporary grading, solicited by Rossi Construction, is still pending.

The goal of the Long-Term Building Committee is to resolve the Education Wing water intrusion issues in 2025. Although the original roof system has performed admirably, we want to ensure that we use the latest products and technology to prolong the functional life of any new roof system. One of our next steps will be to have a structural engineer review the construction of the Education Wing to develop the maximum allowable roof loads. That will tell us what type of equipment can be used to work on the subterranean roof system. A work sequence must be developed so that we do not impact any previous work should the Education Wing roof system need to be replaced.

## **HVAC System Units**

Among others, MPLC has five HVAC units that are aged and have been recommended for replacement by Keystone Heating and Air Conditioning Company. One serves the Sanctuary Outer Ring and is 33 years old, one serves the Education Wing and is 29 years old, one serves the Front Entrance and is 29 years old, one serves the Office and is 18 years old, and the last serves the Fellowship Hall and is 29 years old. The order of replacement is the order in which they are listed above. The Long-Term Building Committee will develop a maintenance schedule to spread out the cost of that work over an appropriate period of time.

## RUMMAGE SALE

Once again MPLC held its annual Rummage sale in 2024. This year it was held on August 9-10th. Over 1000 people came through our doors within those 2 days, but our help to hold the sale started much earlier.

Our donations started on June 16th and our first work day happened on June 25th. This year we had around 25 people who worked weekly from June through August diligently sorting, pricing, and taking in donations to help make our rummage sale a success. Each Tuesday many of us gathered and sorted and priced the week's donations in preparation for the August sale. We had volunteers that worked 5 mornings a week at the 16th Street entrance taking the donations in and down to the Sunday school wing as well.

Then on Sunday August 4th, many of our congregational members stayed after church that morning and helped move all our priced and boxed items into the Narthex, Fellowship Hall, and Mygatts, in preparation for our set up. We are always thrilled, and thankful to have many of our younger members pitch in on this day.

During the days of our sale, about 80 volunteers pitched in to serve in various roles including checkout, security, door monitors, clean up, and even tour guides, to help give us another successful sale!

Our appreciation dinner for all the volunteers, as well as our representatives from our chosen charities who would receive the proceeds, took place on August 20th. Thank you to Peggy Svoboda for once again cooking this delicious meal for us all.

This year our committee nominated and voted for 3 charities which included, Racine Friendship Clubhouse, NAMI, and Main Gallery. Each local charity received a check in the amount of \$3219, (making a grand total profit from the sale of \$9657!).

However, our sale also benefits so many more people than just those at these charities. Our local community looks forward to our sale each year as they line up outside in advance of our opening. Many people find our sale affordable, for things they may need for their families. What we have left over at the end, is shared between the Salvation Army and the AAUW book sale. And we all benefit from recycling our "unused and not needed anymore" things instead of throwing them out.

In 2025, we are planning our next sale for July 17th and 18th and are in need of more volunteers to join our committee. Each year we lose a few people and are in need of replacing them. If you want to come join us, look for the first meeting we will have in the spring to nominate charities for 2025. We are a great group of friendly people and would love to have you.

# STEWARDSHIP

### Pastor Beth Ann L. Stone



#### "For where your treasure is, there your heart will be also." (Matthew 6:21)

2024 was something of a comeback year in terms of members committing to give in support of God's mission through MPLC. The number of households making financial commitments increased from 177 in 2023 to 184 in 2024. Many of those commitments included people giving through automatic bank transfers on a schedule they determined (such as weekly, biweekly, or monthly). Such giving can contribute to a steadier income stream for the congregation across the year as well as helping givers stick to their own plans to give.

In 2024, as in 2023, about 1/3 of all contributions came from givers who hadn't made a giving commitment (or pledge). All offerings are important to the support of our congregation and the mission we share. Our Finance Committee and Congregation Council do their best to make sound choices to steward the congregation's resources, even while the giving side of the ledger is less certain than in some years past.

"Where Your Heart Belongs" was the theme of our fall 2024 stewardship appeal, based on Jesus' words in Matthew 6:21: "For where your treasure is, there your heart will be also." We remembered God's gift of belonging...to God through our baptism, and to Mount Pleasant Lutheran Church through the work of God's Holy Spirit. We're called to continue to share that gift with others as we treasure it ourselves.

Beyond our regular offerings, here are a few of the other ways MPLC shared our gifts and supported our neighbors and ministry partners in 2024:

- Our Thanksgiving and midweek Advent service offerings last year, totaling \$1,369, were designated for The Hospitality Center of Racine.
- Christmas gifts for 40 participants in RADD (Recreational Activities for the Developmentally Disabled) were provided in November by MPLC donors who picked up ornaments from our Giving Tree.
- Our Confirmation students again pooled their collected money to purchase plenty of Thanksgiving dinner fixings for the Holy Communion Food Pantry in November.

- Year-round, many members brought food donations to put in the designated bins in the Donation Station in our narthex. Our "noisy offering" collection in August yielded an extra donation of \$424 to the Holy Communion Food Pantry, and \$424 to support MPLC's Little Free Food Pantry.
- Sunday School offerings given throughout the 23-24 school year went to God's Global Barnyard program, enough to support a community vegetable garden and two bee colonies for a needy community.
- Last fall, Sunday School students collected items to complete 50 school kits for Lutheran World Relief. They also made dog toys for the local Humane Society.
- Our quilters donated four quilts to Lutherdale Camp's annual auction fundraiser, and another 80 quilts to Lutheran World Relief. MPLC's parking lot also served again as the collection site for LWR donations last October.
- All proceeds from MPLC's Rummage Sale in 2024—\$9,657
   —were donated to the following local charities: NAMI
   (National Alliance of the Mentally III), Main Gallery
   Summer youth program, and Racine Friendship
   Clubhouse.
- MPLC hosted two Blood Drives for the American Red Cross, in January and June.
- Members provided dozens of cookies for the bake sale at Empty Bowls Racine, and hosted two bowl-painting events in 2024 for that event, fighting hunger in Racine.
- Volunteers and donors provided ingredients, prepared, packaged and distributed 100-130 meals six different times in 2024 for the shared Community Meal program at Living Faith Lutheran Church.
- Volunteers donated ingredients, prepared, served and hosted MPLC's monthly Open Table meal, serving 60-100 neighbors and guests each month.

Thank you for your giving to support God's mission through MPLC in 2024, and for all of the ways you contributed to the outreach listed above! Together, we made a difference in our community and beyond for the sake of Jesus.







## YOUTH MINISTRY

In 2024, MPLC and our neighboring ELCA congregation, Lutheran Church of the Resurrection, again worked together to provide ministries with our middle and high school students.

#### CONFIRMATION

MPLC was the location for middle schoolers from both congregations to gather for Wednesday night Confirmation classes and combined small groups. Scott Reske ably taught Confirmation large group learning in Mygatts (through the spring) and in the sanctuary (starting in the fall).

Four young people from MPLC attended Confirmation Week at Lutherdale in June, with the support of the congregation paying half of the registration fee: Aaron Arndt, Nathaniel Thorn, Katelynn Thorn, and Zack Steenrod. It is MPLC's



expectation that students will attend a week of Confirmation camp either the summer after 7th or 8th grade.

Two Confirmation Group Guides concluded their time as guides last spring after their students finished; thank you to Stew Nagao and Jenny Jarvis for your leadership! Nate West was joined by Kathy Behm as guides in the fall, along with two guides from LCR. There are currently 14 students in Confirmation from MPLC and 11 from LCR.

On Reformation Sunday, five students affirmed their baptism as they were confirmed: Aaron Arndt, Graycen Jarvis, Garret Kildahl, Nathaniel Thorn, and Danielle West.





### HIGH SCHOOL YOUTH

In the first half of 2024, a group of 16 youth and adults from both congregations met monthly to get ready to attend the ELCA Youth Gathering in New Orleans in July. We held fundraisers, learned about New Orleans, created a covenant, and made logistical plans for the event, to which we flew. In New Orleans we heard inspiring speakers and great bands, worked in the Louisiana heat on our morning of service, sweated our way around the French Quarter for a photo scavenger hunt, took a paddleboat ride in the rain, and ate some incredible food with thousands of new friends



from around the country! It was amazing to experience the church through the energy of so many young people, and to praise God together.

Besides Gathering prep, we also met many Sunday nights for various Youth Night activities, like bowling, carving pumpkins, making care packages, and more. Last fall, the pattern of meeting weekly was reduced without the impetus of Youth Gathering Prep. A large portion of the active youth from the past few years have either graduated or are now seniors. There is a natural transition time coming as we rebuild a new generation of youth ministry.







### **FUTURE DIRECTIONS**

Both MPLC and LCR had pastoral transitions in 2024, making our cooperation all the more important in 2024. In the last third of the year, both LCR and MPLC called second pastors who would have youth ministry responsibilities, leading us to conclude that the end of the '24-25 school year is a good time for us to transition back to developing our own congregation-based youth ministries. We hope still to welcome each other to occasional larger events in each other's congregations in the future, even as we support and cheer on each other's distinctive programs. With Pastor Nathan's call to MPLC, we will continue in 2025 to rebuild a Youth Committee of invested adults who want to help us grow in faith with our young people.

### **Greater Milwaukee Synod FY2023 Thank You**

We believe that the ELCA's members, congregations, synods and churchwide organization are called to be church together. Every year around \$1.6 billion is shared as regular offerings to ELCA congregations and worshiping communities. Over 5% of that generosity is shared with our 65 synods, a portion of which is then shared with the churchwide organization. We call this Mission Support. In FY2023, the Greater Milwaukee Synod shared \$720,945 directly in Mission Support for ELCA churchwide ministries. Whether utilized locally, regionally, nationally or internationally, Mission Support enables us to have a greater impact in communities — working together to share God's abundant grace with others.

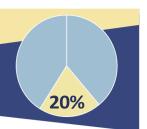

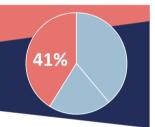
